

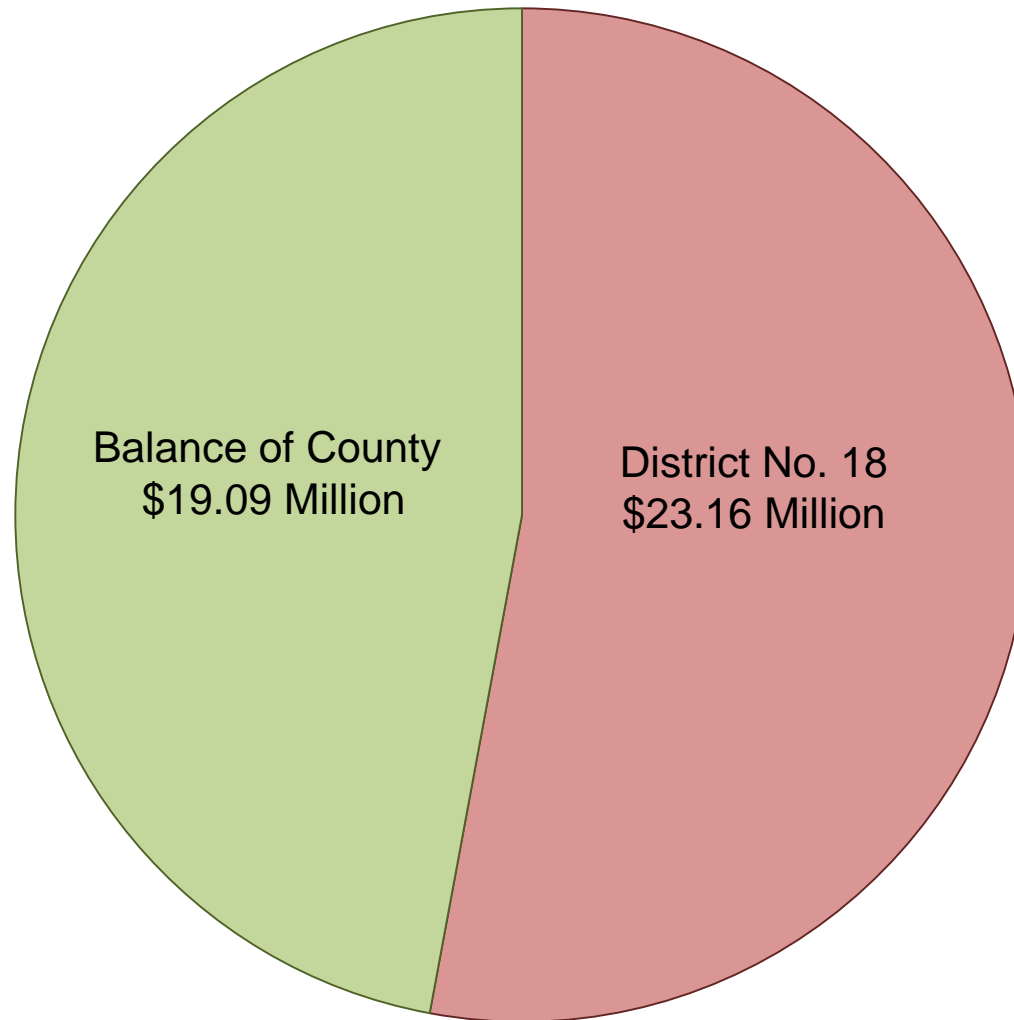

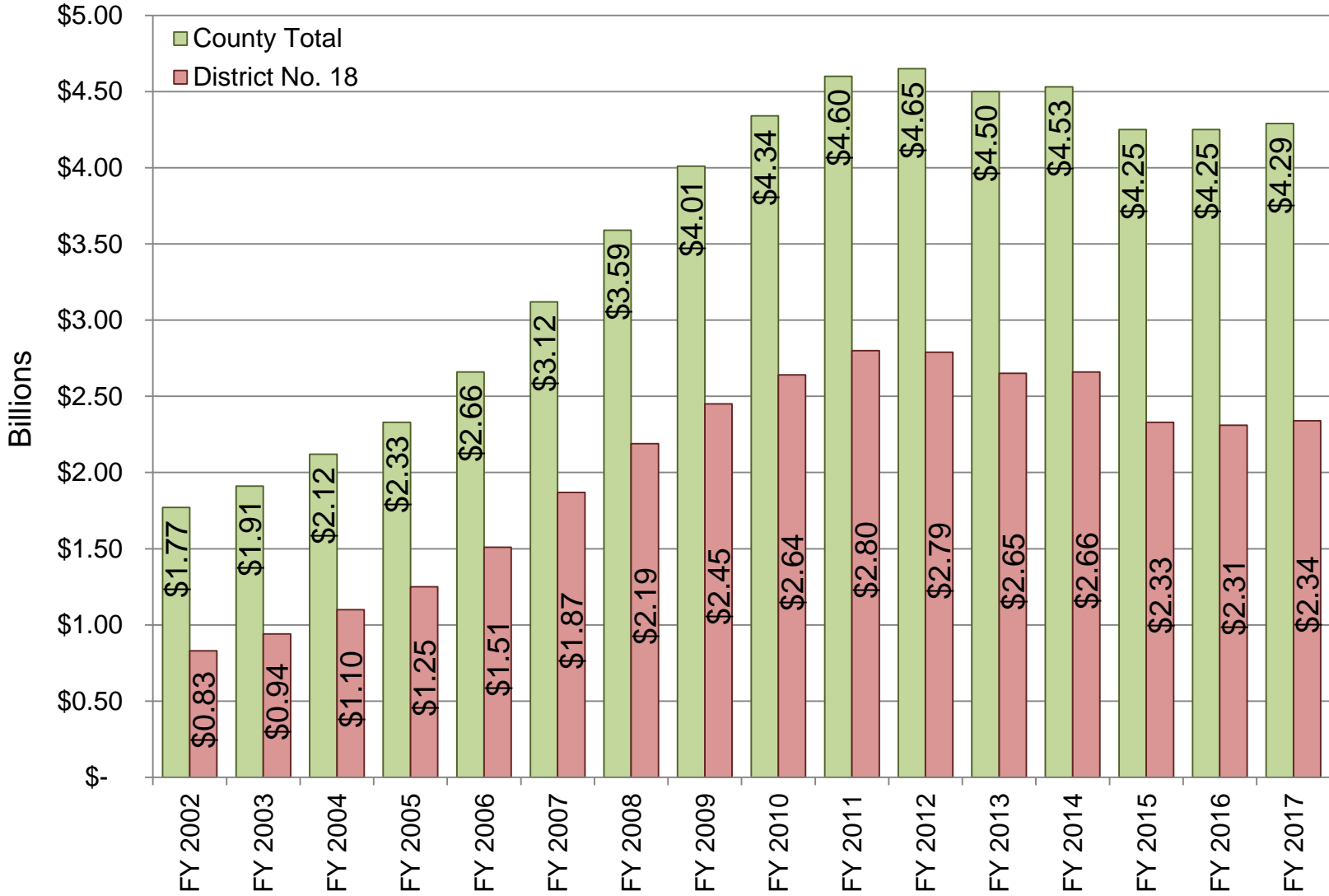

REAL ESTATE TAX REVENUE - 2017 BUDGETED

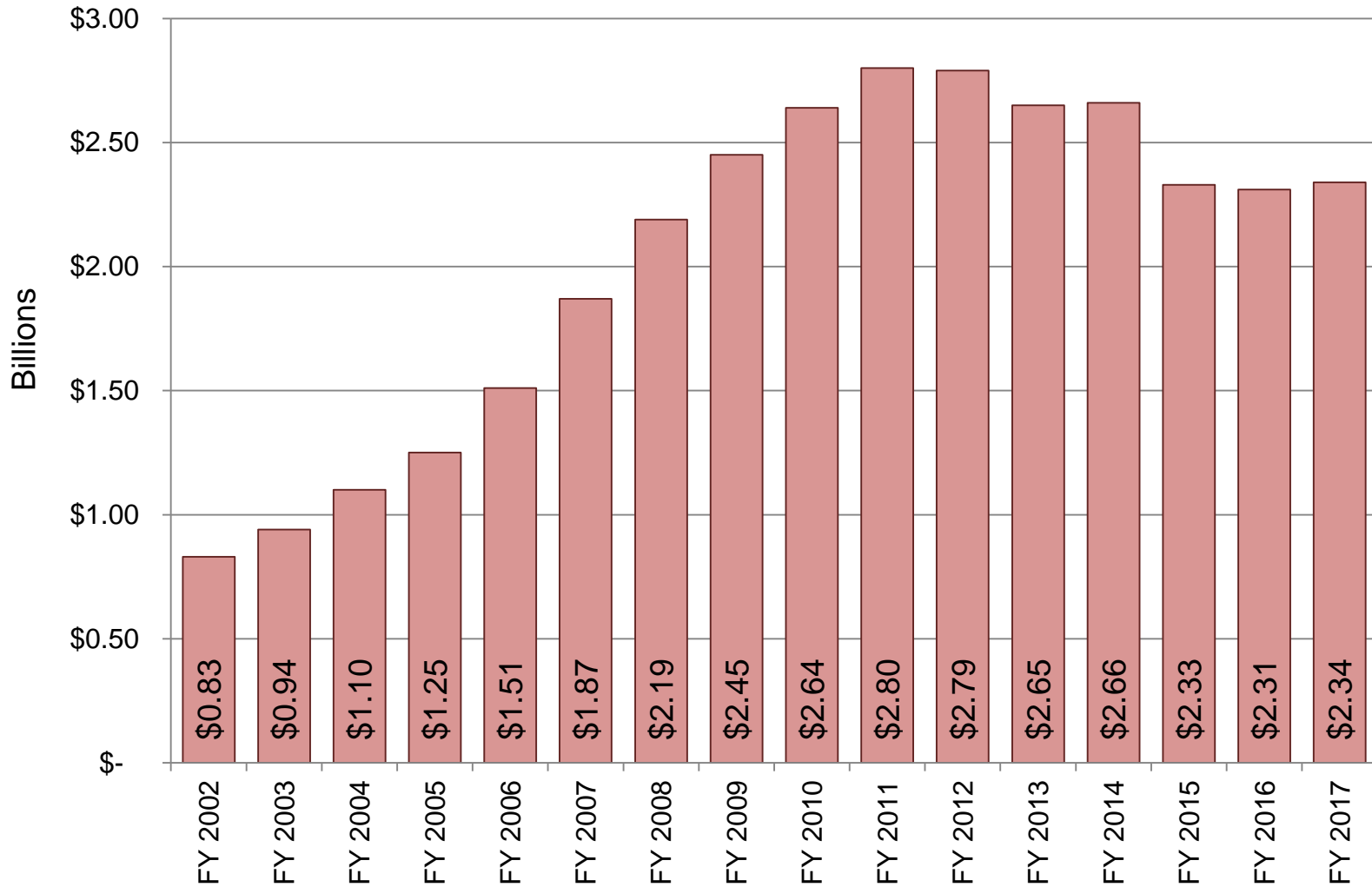


ASSESSABLE TAX BASE



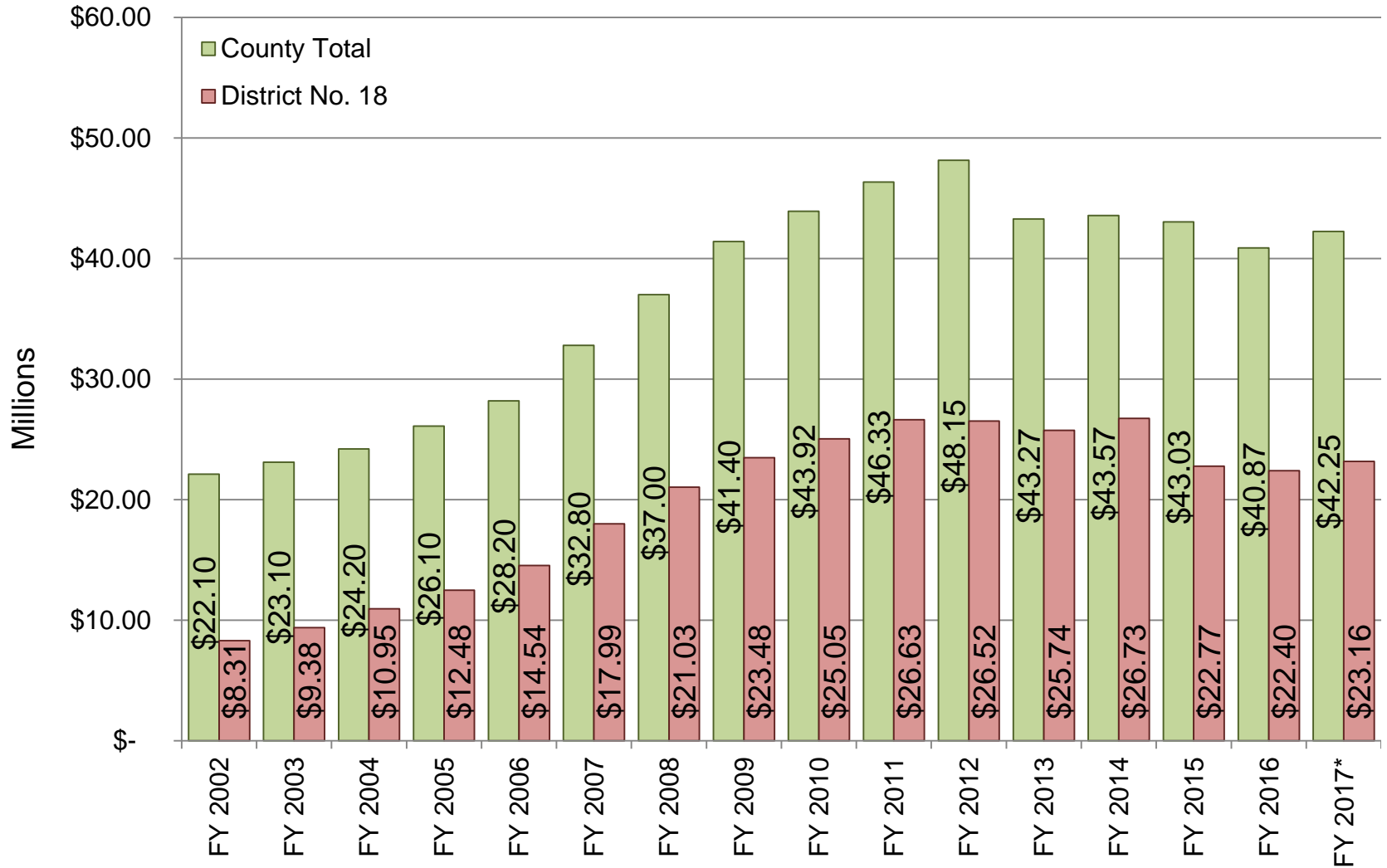

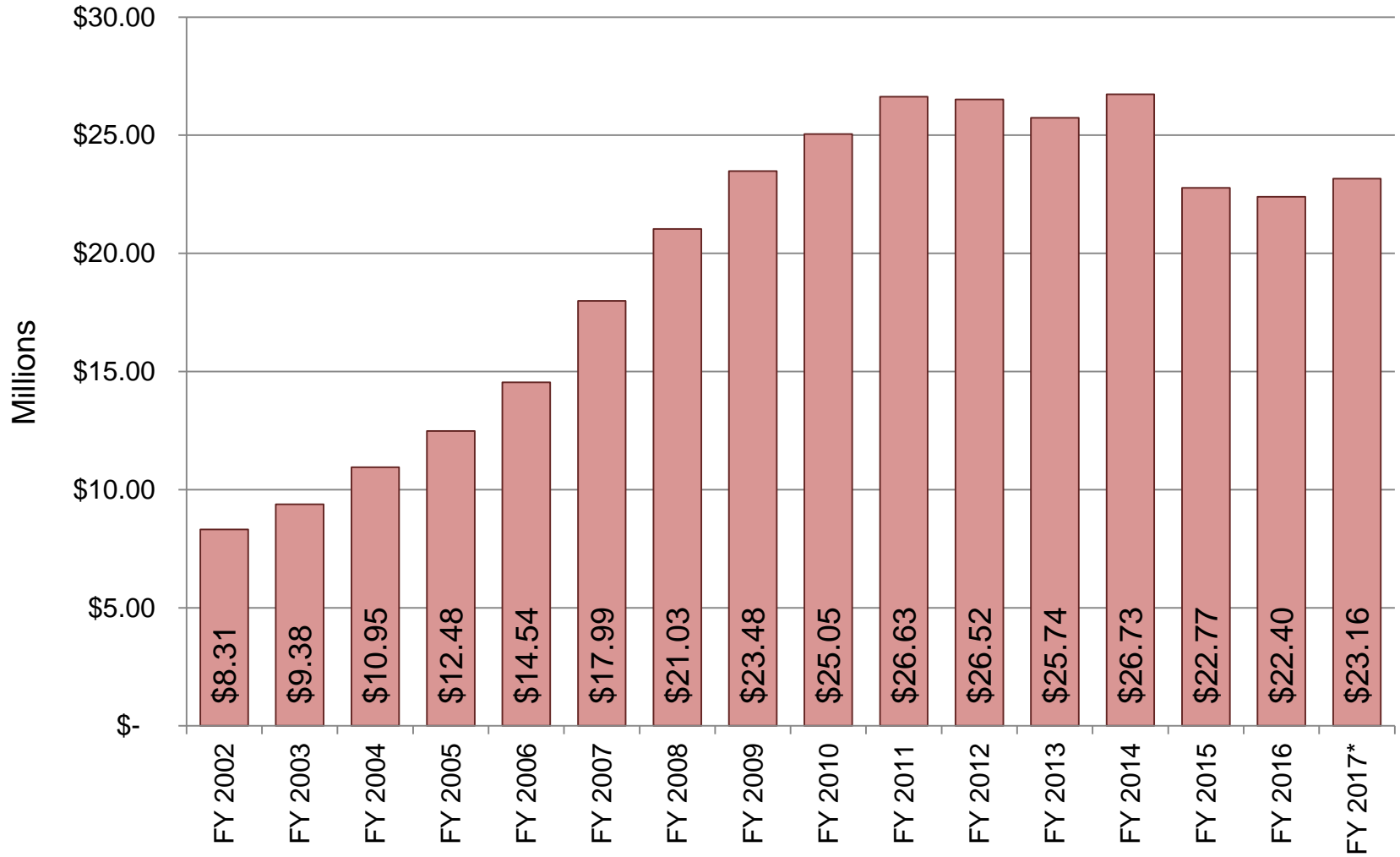
REAL ESTATE TAX REVENUE

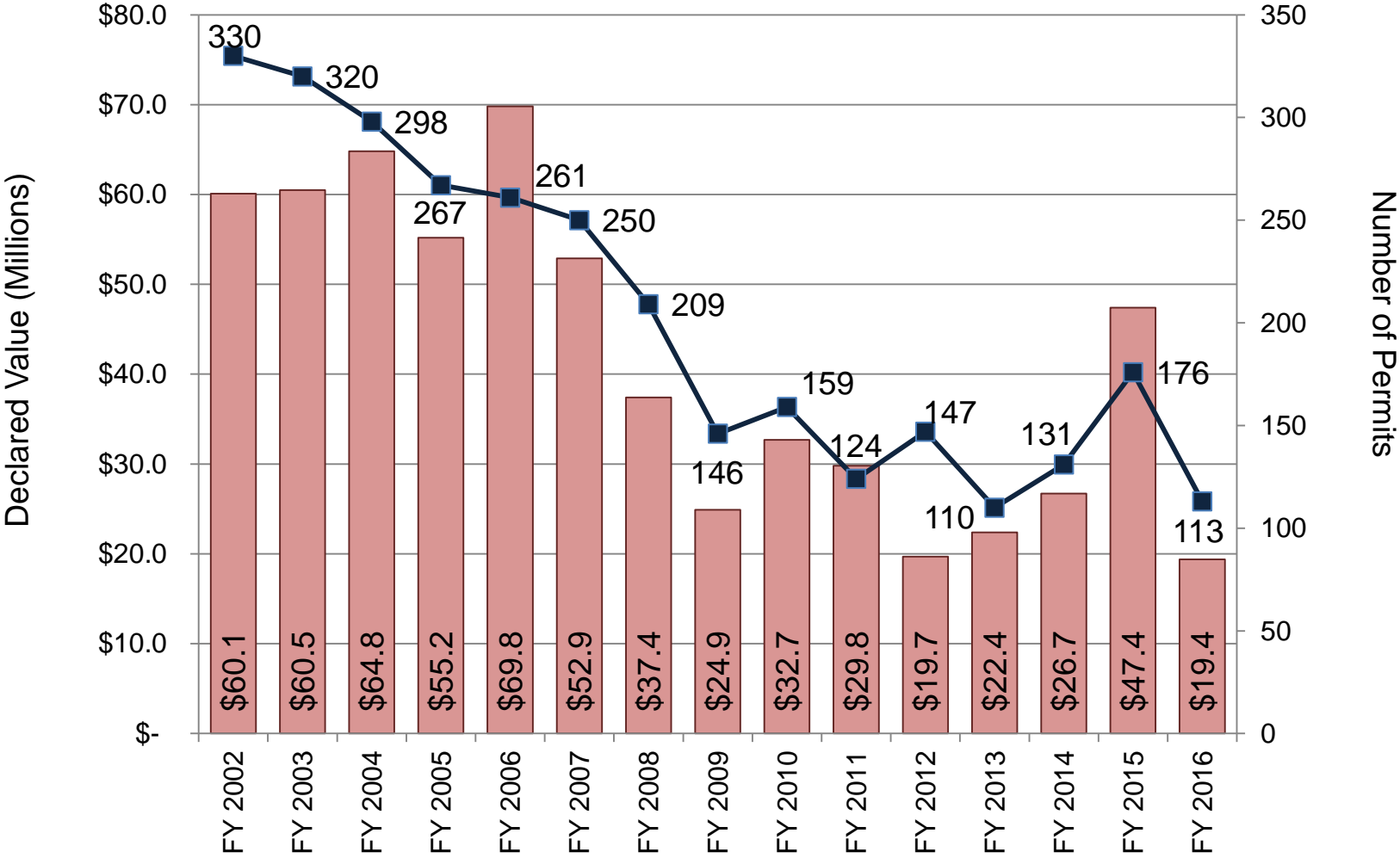
REAL ESTATE TAX REVENUE (District No. 18)

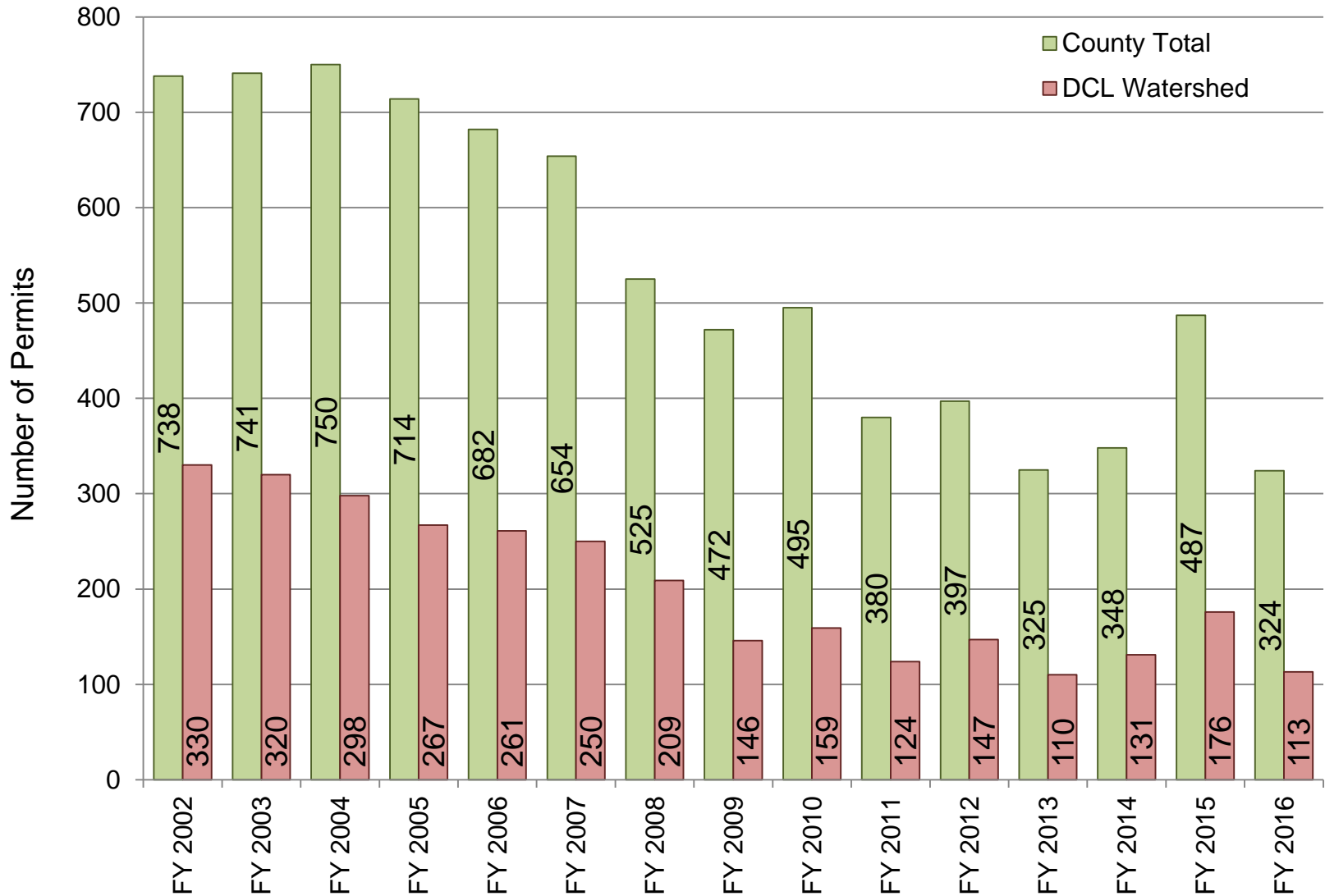

BUILDING PERMITS (DCL Watershed)



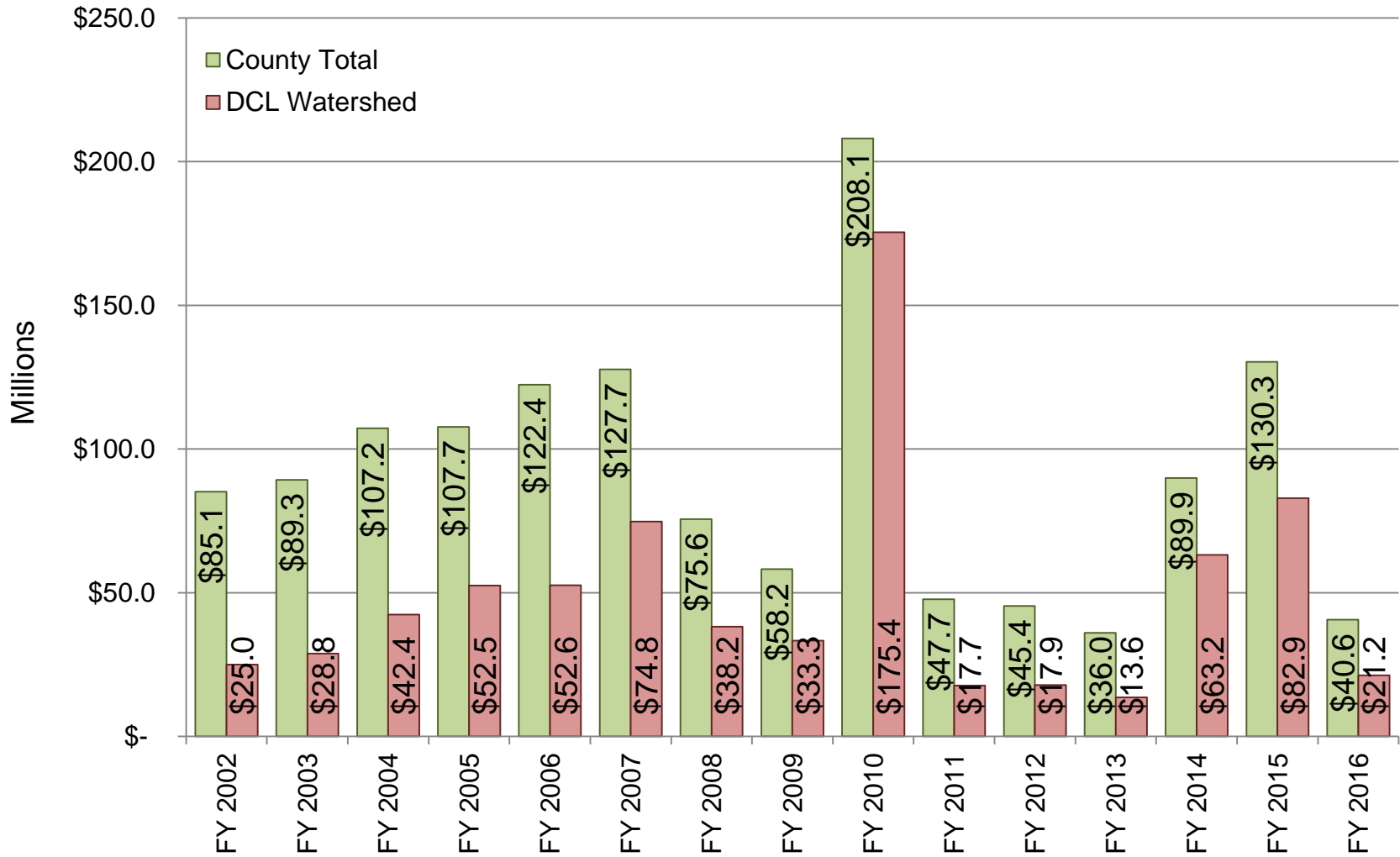

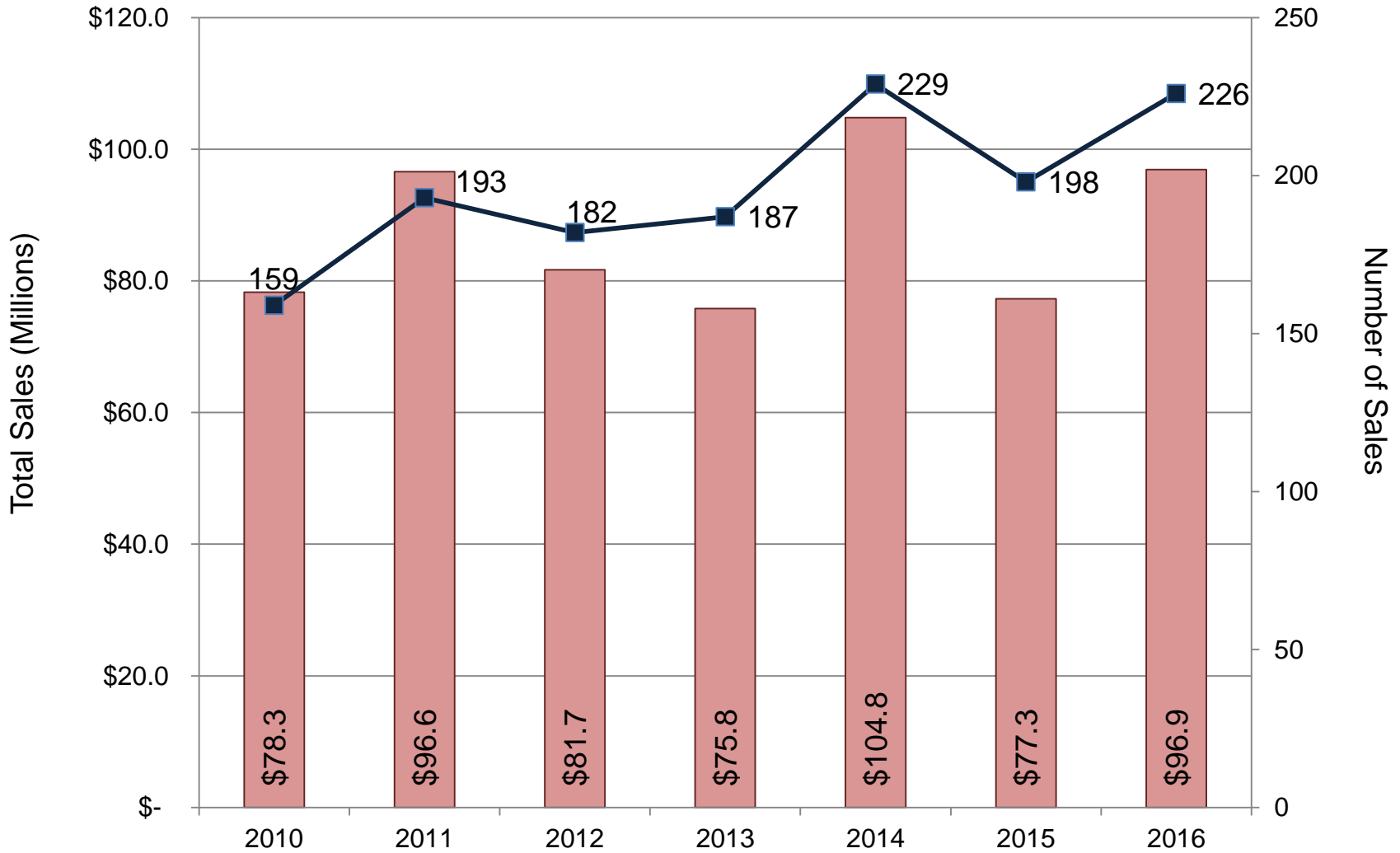
DECLARED VALUE OF BUILDING PERMITS

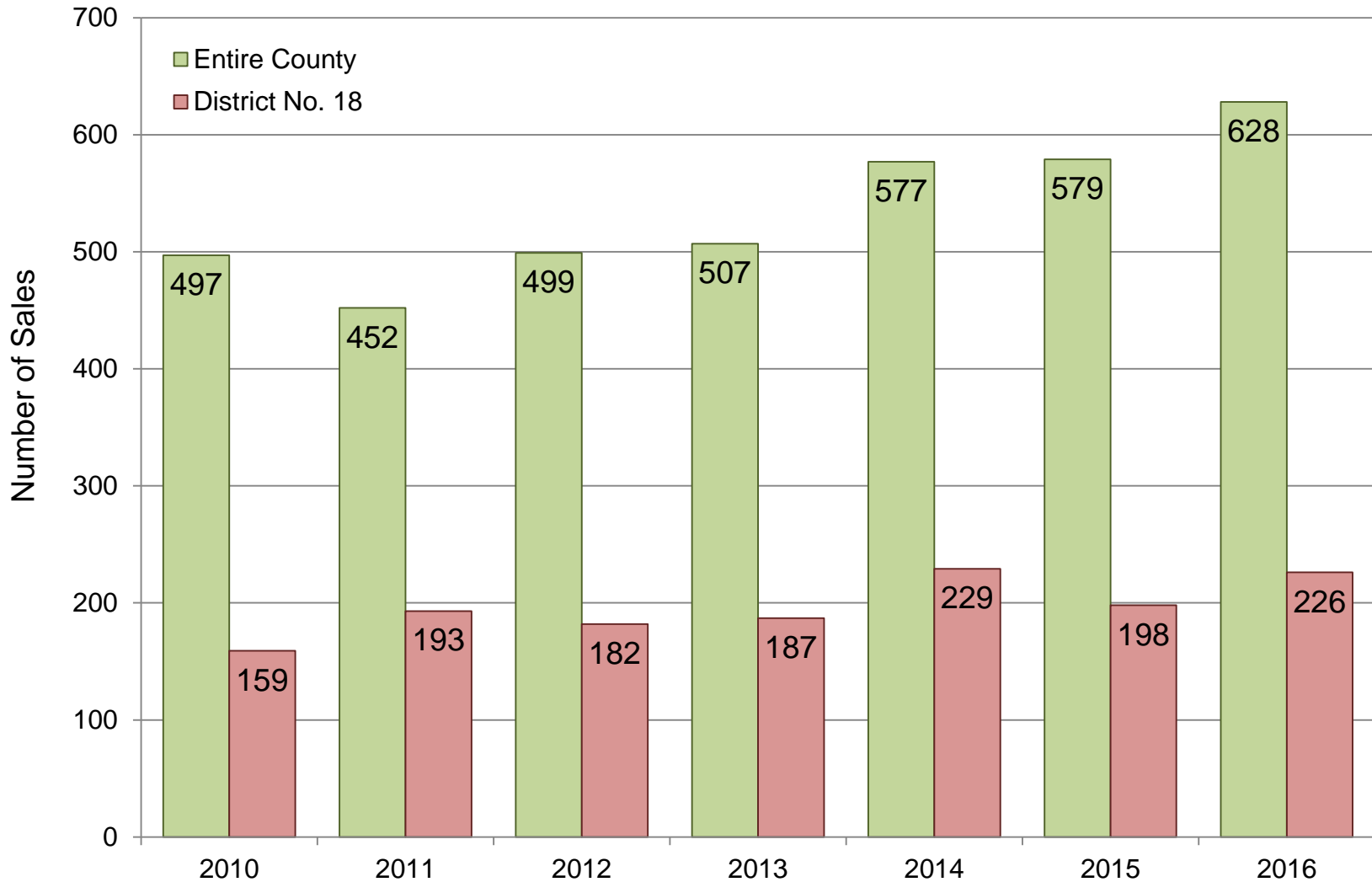

RESIDENTIAL IMPROVED REAL ESTATE (District No. 18)



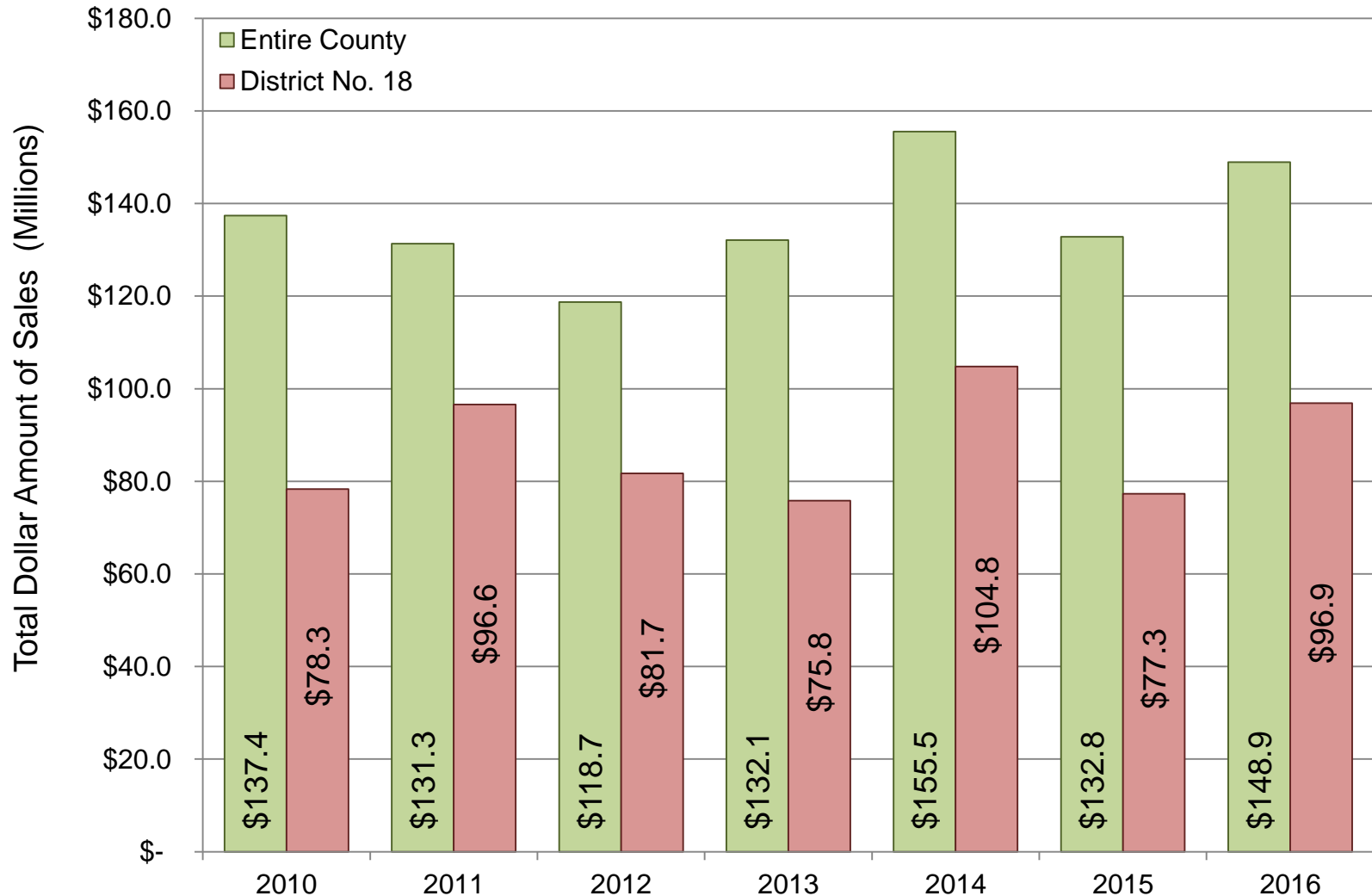

NUMBER OF RESIDENTIAL IMPROVED REAL ESTATE SALES



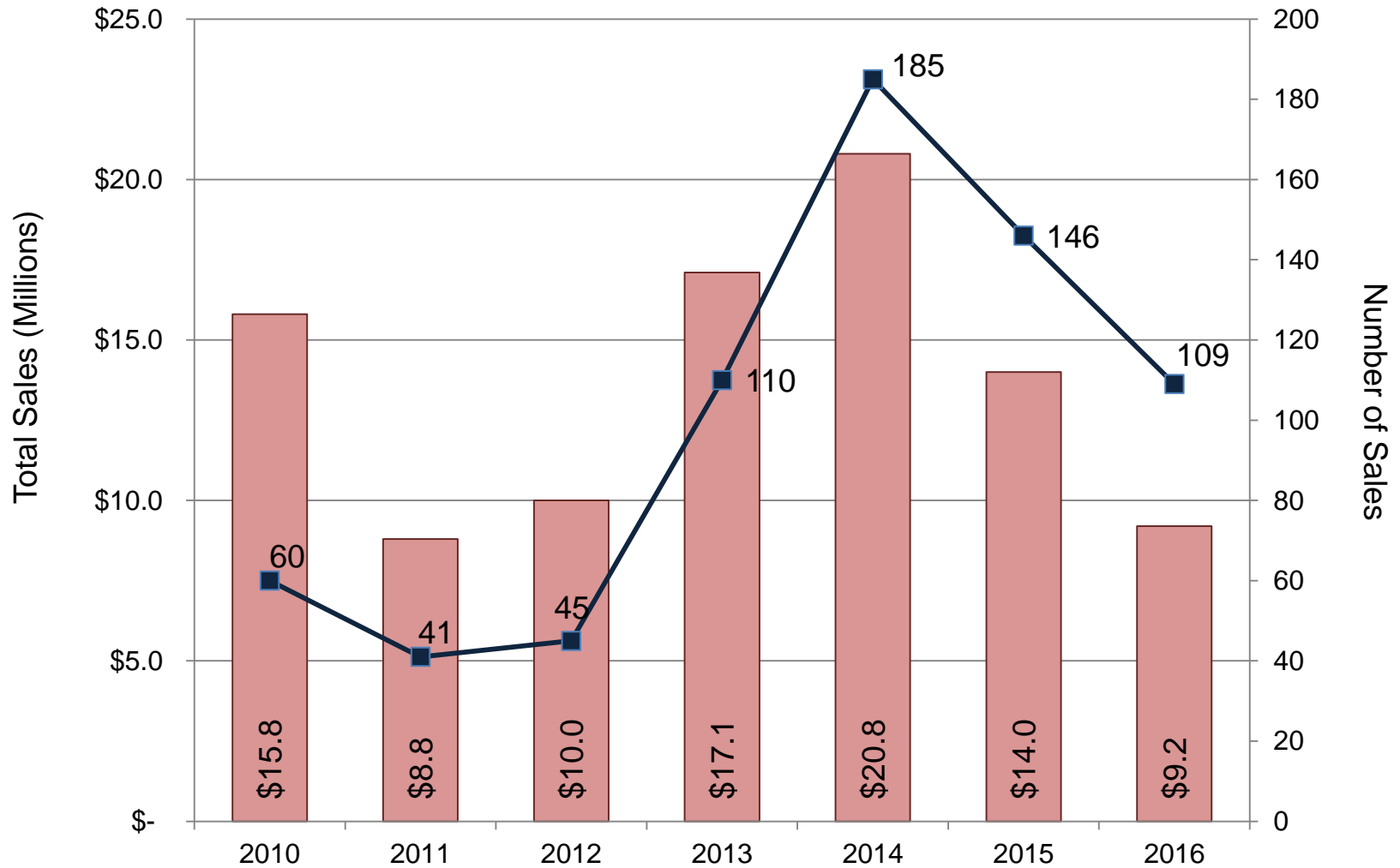

TOTAL DOLLAR AMOUNT OF RESIDENTIAL IMPROVED REAL ESTATE SALES



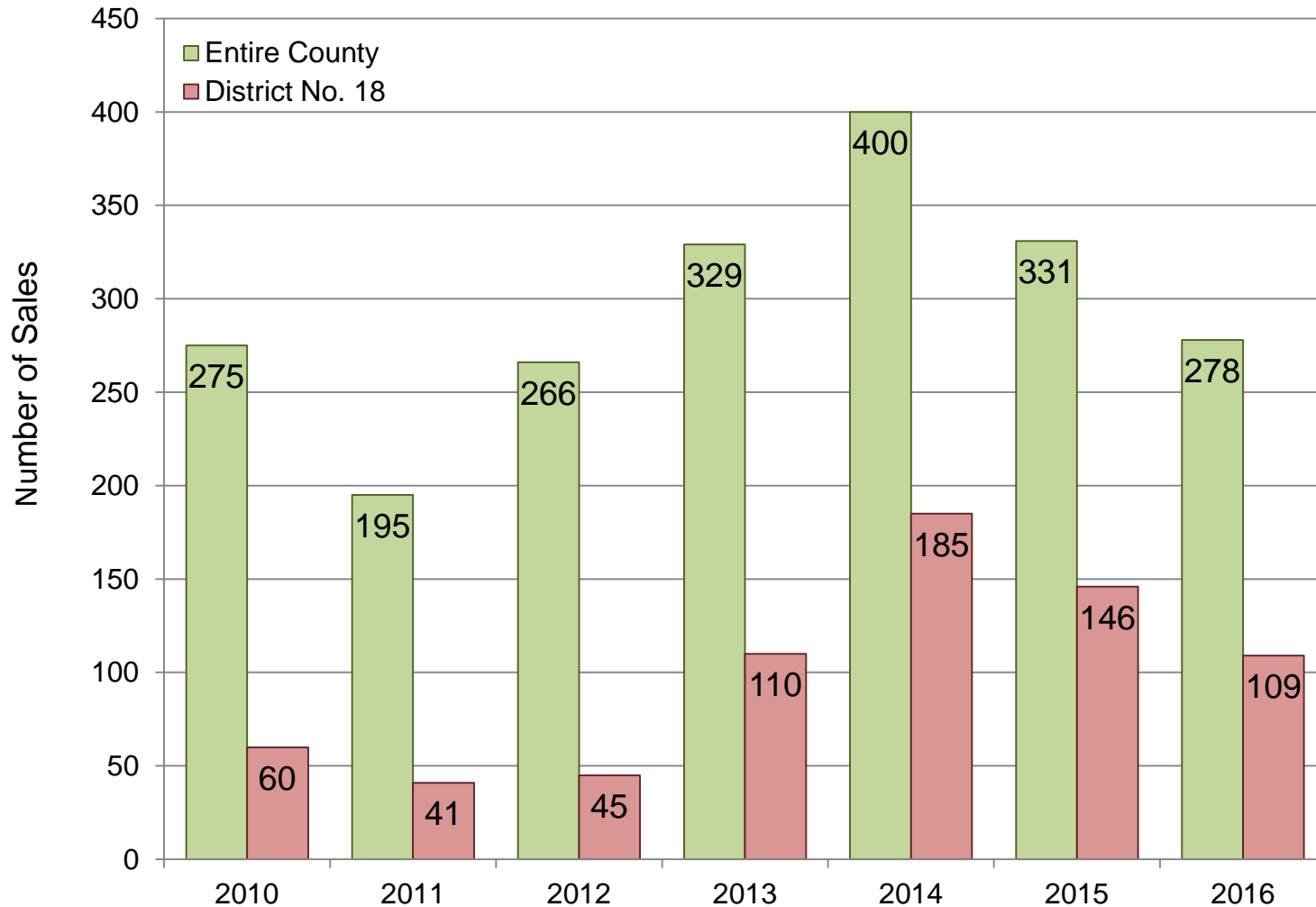

RESIDENTIAL UNIMPROVED REAL ESTATE SALES (District No. 18)



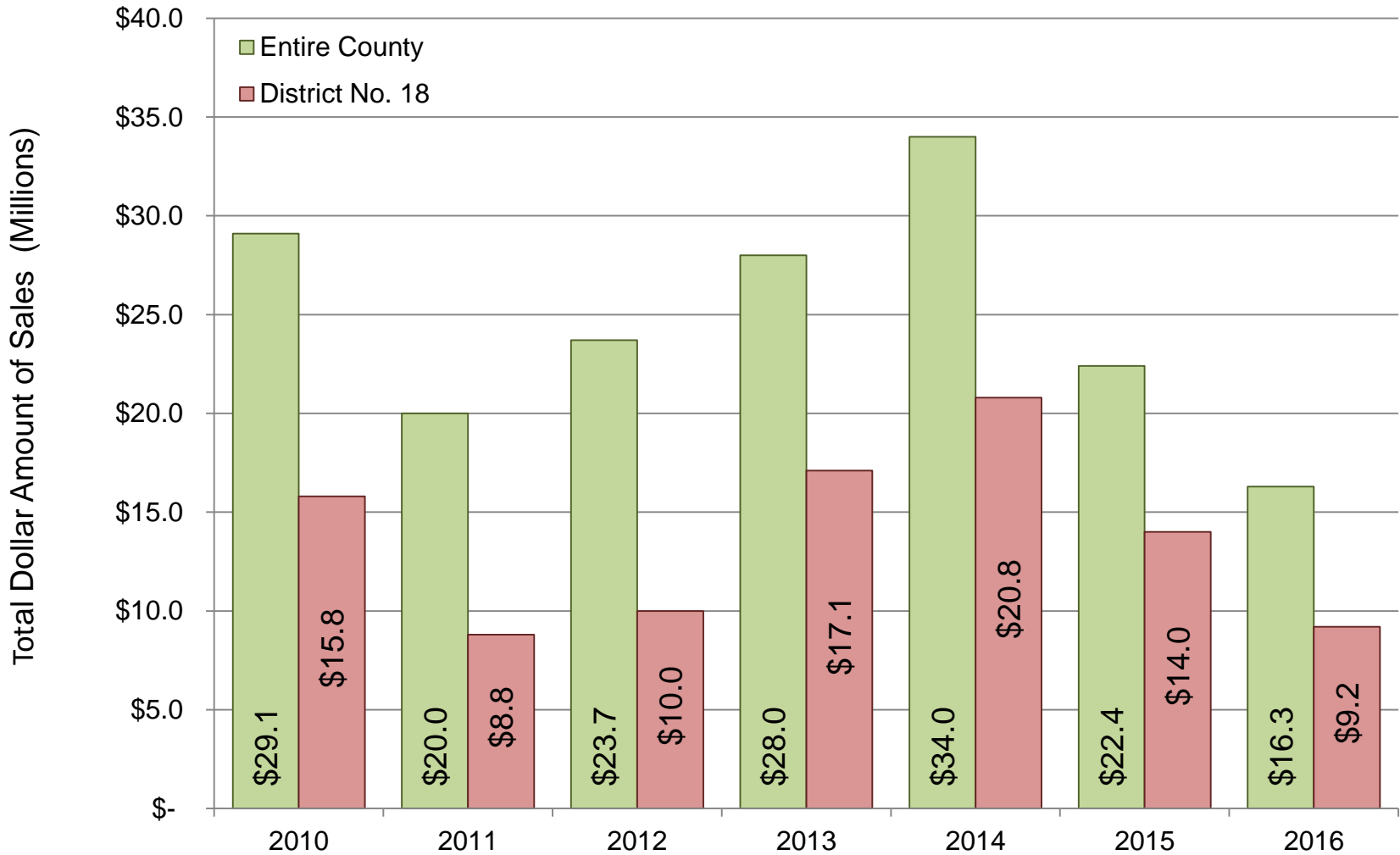
